

Scholarship Details

Up to ten \$250 scholarships will be awarded at the end of March, June, September, and December. Deadlines to apply each quarter are:

March 26, 2021
June 25, 2021
September 24, 2021
December 30, 2021

Once applications are received, they are good for the remainder of the current calendar year. If your application is not selected in one quarter, it will be considered in the remaining quarter(s) of that calendar year. You may, however, submit a new, updated application if your family/living circumstances change. Eligibility of a program and winners selected will ultimately be determined at the discretion of the Foundation Selection Committee, and the decision is final. Only winners will be notified by UFCW Local 75 Foundation, Inc.

Scholarships will be dispersed in the form of reimbursements for eligible child care expenses.

Eligibility Requirements

Must be a UFCW Local 75 member in good standing for at least 90 days prior to being awarded a scholarship. Winners must remain members in good standing to collect their scholarship. Members of the UFCW Local 75 Staff and Executive Board are not eligible. Members may receive the scholarship no more than one time per year. Must be the parent or legal guardian of (a) dependent child(ren) enrolled in full-time or part-time child care.

Child care must be provided during the member's working hours from a licensed care center or home, or legally certified child care provider.

Application Checklist

- Essay
- Receipt(s) for child care expenses incurred **(must total at least \$250)**
